PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

May cause slight eye and skin irritation. Do not get this product in eyes, or on skin or clothing. Avoid breathing dust or vapours. Avoid skin contact. PROTECTIVE CLOTHING AND EQUIPMENT

FIRST AID

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
