**DIRECTIONS FOR USE:** Apply powder, using a hand or pressure duster, into cracks and crevices where insects breed and hide. A light dusting is all that is required. Leave undisturbed for two weeks. Reapply as necessary. Cover or remove food, dishes, and cooking utensils before applying. Avoid pantry shelves and other places where food is stored. Apply dust only as a crack and crevice application.

**CAUTION:** In meat packing, food service establishments and food processing plants, only apply when plant is not in operation. No exposed food products, ingredients or packaging materials to be left in the room. Cover food-handling equipment. Any treated surface that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after spraying and before reuse for food processing.

**PRECAUTIONS:** Apply/use only in areas inaccessible to children and pets **KEEP OUT OF THE REACH OF CHILDREN.** Do not apply as a broadcast application. Store in a cool, dry, well ventilated place, away from food and feed. Avoid contact with skin, eyes, and clothing. Wash thoroughly after handling and before eating, drinking or smoking. Avoid breathing dust. Do not contaminate food or feed. Do not contaminate any body of water. Do not spill or dump in areas underlain by roots of valuable plants.

Wear long pants, long-sleeved shirt, chemical resistant coveralls, chemical resistant gloves and a NIOSH approved N95 (minimum) filtering face piece respirator (dust mask) that is properly fit tested when loading or applying boron as a dust/powder.

Visible dust/powder must be removed or wiped away after application to voids.

**SYMPTOMS OF POISONING:** Ingestion and absorption may cause nausea, vomiting, diarrhea, abdominal cramps, skin rash, circulatory collapse, delirium, convulsions and coma. Chronic exposure may cause dry skin, skin rash and gastric disturbances.

**FIRST AID:** In case of poisoning, call a physician or contact a poison control centre IMMEDIATELY.

**If swallowed** - Call a poison control center or doctor immediately for treatment advice.

Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing** -

Take off contaminated clothing. Rinse the skin immediately with plenty of water for 15-20 minutes. Call a poison control center, or doctor for treatment advice.

**If in eyes** - Hold the eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. Call a poison control center, or doctor for treatment advice.

**If inhaled** - Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.
