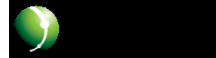

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Wash thoroughly with soap and water after handling. Avoid contamination of food and feedstuffs. Do not use in commercial food/feed processing, preparation, food/feed storage or serving areas. In the home, all food/feed processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Exposed food/feed should be covered or removed. Remove pets, birds, and cover fish aquariums before spraying and turn aquarium systems off.

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 50°C may cause bursting. Do not apply this product around electrical equipment due to possibility of shock hazard.

FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. **If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. **If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. **If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

DIRECTIONS FOR USE:

Kills Wasps, Hornets, and Yellowjackets

SHAKE WELL BEFORE USE

USE RESTRICTIONS:

- Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift.
- Do not allow adults, children, or pets to enter the treated areas until sprays have dried.
- Do not use in food handling, storage or preparation areas while food is present.
- All indoor and outdoor applications must be limited to spot or crack-and-crevice treatments on structural surfaces only or to the direct application to nests. Do not apply as a space spray or broadcast treatment. Do not treat furniture.
- Perimeter/spot application is defined as an application in a wide band or strip around the perimeter of the room or over a small area (< 2 ft²/0.2 m²). Crack and crevice applications are defined as an application with the use of a pin stream nozzle, into cracks and crevices in which pests hide or through which they may enter a building.
- Do not apply directly to sewers or drains, or to any area, like a gutter, where drainage to sewers, storm drains, water bodies, or aquatic habitats can occur, except as directed by the label.
- Do not water treated area to the point of runoff.
- Do not make applications during rain.
- DO NOT apply to any body of water. Do not apply within 7.6 m (25 feet) of lakes, streams, ponds, estuaries, oceans or other waters.
- DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.
- Do not spray vegetation. If desirable foliage is contacted with spray, rinse with water immediately.

OUTDOOR USES: Apply on nests and as a spot or crack and crevice treatment under eaves, near window frames, doorways, building surfaces protected from rainfall/runoff, carports, picnic areas, and outdoor play areas.

INDOOR USES: Apply on nests and as a spot or crack and crevice treatment inside homes where pests are found. Apply only in locations where food or feed are not exposed.

Before spraying insects, shake can and give the can a short burst away from the pest to ensure proper pressure.

Kills Wasps, Hornets, and Yellowjackets on Structural Surfaces:

Spray 1-2 seconds until surface is moist to kill listed insects under eaves, around screens, windows, doors, patios, cracks, holes and crevices or wherever listed insects are found or may enter the home. Apply directly to the insect if possible. Users should test a small, inconspicuous area first to ensure there are no adverse effects such as staining, discolouration or corrosion prior to treating an entire area. This product may stain or adversely affect vinyl, painted, and plastic surfaces. Avoid application to asphalt roofing shingles as staining may occur. Test in an inconspicuous area and re-check in a few hours before using in areas where spray may contact these surfaces. Repeat if pests continue to be a problem.

Nest Spray:

For/(To Treat) Nests of Wasps, Yellow Jackets (Yellowjackets) and Hornets:

1. Spray open-combed nest at sunrise or sunset when insects are least active. Spray enclosed, single-opening nest during the day when activity is observed.*
2. Stand a safe distance from the nest. Do not stand directly underneath.
3. Shake can well before each use.
4. Hold can upright and point spray nozzle toward nest with wind at your back to avoid spray drift. Push button to spray.
5. Aim nozzle at the opening in the nest and spray until saturated. This product's spray will also kill insects that return to the nest.
6. Wait at least 24 hours before removing the nest. The nest must be dry before removing.

*Do not treat enclosed nests unless you can clearly see the entrance hole at the base. Spray directly into entrance hole. Repeat spray into entrance hole after foam disappears **until can is empty or no more hornets are seen. Leave area quickly after each spray.**

DISPOSAL: When container is empty, press valve to release all remaining pressure. Wrap and dispose of empty container with household garbage. Unused or partially used products should be disposed at provincially or municipally designated hazardous waste disposal sites.

STORAGE: Store in a cool dry area away from heat or open flame. To prevent contamination store this product away from food or feed.
