DIRECTIONS FOR USE:

Kills mosquitoes, house flies, horn flies, stable flies, fruit flies, lesser house flies, Indian meal moths, Mediterranean flour moths, Angoumois grain moths and clothes moths.

SHAKE WELL BEFORE USE. HOLD CONTAINER UPRIGHT. APPLY IN SHORT BURSTS.

USE RESTRICTIONS:

- Do not allow adults, children, or pets to enter the treated areas until sprays have dried.
- Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift.
- Do not treat mattresses, clothing, linens etc. For clothes storage areas, remove articles prior to treatment. If articles come into contact with treated surfaces, wash prior to use.
- Do not remain in treated area. Exit area immediately and remain outside the treated area until aerosols, vapors, and/or mists have dispersed.
- Remove or cover exposed food and drinking water before application.
- Remove or cover dishes, utensils, food processing equipment and food preparation surfaces or wash them before use.
- Remove pets and birds and cover fish aquariums before spraying.
- All indoor and outdoor applications must be limited to spot or crack-and-crevice treatments only. Do not apply as a space spray or broadcast treatment.
- DO NOT apply to any body of water.
- Do not apply within 7.6 m (25 feet) of lakes, streams, ponds, estuaries, oceans or other waters.
- Users should test a small, inconspicuous area first to ensure there are no adverse effects such as staining, discolouration or corrosion prior to treating an entire area.
- DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

For Indoor Use:

TO KILL LISTED FLIES, MOSQUITOES AND SMALL FLYING MOTHS ON SURFACES:

SPOT TREATMENT ONLY: Hold can approximately 45 to 60 cm (18 – 24 inches) from infested surfaces and apply a one second burst directly to the pest if possible. Avoid wetting upholstered furniture and draperies. Use caution on light or delicate upholstery fabrics, draperies, or carpet. Sweep up and discard fallen insects. Repeat if pests continue to be a problem.

For use in residential areas (e.g., apartments and homes). May also be used to treat linen/clothes storage areas (e.g., chests, closets), furniture and rugs.

For Outdoor Use:

TO KILL LISTED FLIES, MOSQUITOES AND SMALL FLYING MOTHS ON SURFACES:

Thoroughly spray as a spot or crack and crevice treatment to outdoor structural surfaces including building surfaces protected from rainfall/run-off, screens, doors, under eaves, door frames, window frames, foundations, patios, garages, refuse area or other similar places where insects may enter or congregate. Apply until damp but not to the point of runoff. Contact as many insects as possible with the spray. Repeat if pests continue to be a problem.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Potential skin sensitizer. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Wash thoroughly with soap and water after handling. Avoid contamination of food and feedstuffs. All food/feed processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Exposed food/feed should be covered or removed. Remove pets, birds, and cover fish aquariums before spraying.

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 50°C may cause bursting.

FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. **If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. **If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. **If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

TOXICOLOGICAL INFORMATION:
