DIRECTIONS FOR USE

INDOOR USE: Prior to treatment, all food sources must be removed or made unavailable to rats and mice. Place RatRid bait where there are signs of rat and mouse activity such as fresh droppings, inside or near rat runs and feeding areas. At each bait point, place RatRid into baits stations, small bowls or feeding trays. Mice and rats are sporadic feeders, so several bait stations are required. Place bait points approximately 1.8 m (6 feet) apart throughout the infested area. For rats use 40-60 g (1 1/2 to 2 ounces) per bait point and for mice use 10-15 g (1/3 to 1/2 ounce) per bait point.

Protect bait points from non-target animals and from water. Inspect bait points frequently (e.g. daily) and replace any eaten bait. Replace any bait that becomes wet and relocate the bait point in a dry location. Keep topping up bait points until there is no more evidence of feeding for at least 48 hours.

Note that rats require at least 6 or 7 days of continuous feeding only on RatRid for death to occur and mice require at least 3 days of continuous feeding only on RatRid for death to occur.

Rats and mice may carry disease. After treatment, remove bait containers, all remains of bait and any rat or mouse carcasses and dispose of safely. Carcasses and leftover bait can be buried or placed in an appropriate trash receptacle for disposal at an approved refuse site.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Keep away from children, pets, domestic animals and wildlife. Avoid breathing/inhaling any dust generated when handling RatRid. It is advisable to wear protective gloves to dispose of any dead mice and rats or handle bait and/or bait stations that have been visited by mice and rats. Always wash hands after handling carcasses or bait and bait stations.

FIRST AID: If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: DO NOT reuse the empty containers. Dispose in household garbage. Unused or partially used products should be disposed at provincially/territorially or municipally designated hazardous waste disposal sites.

STORAGE: Store this product away from food or feed.
