TO KILL FLYING INSECTS:

For **FLIES and MOSQUITOES**: For the average size room (30 cubic metres) spray in a slow sweeping motion for 8 to 10 seconds starting from the middle of the room and backing toward the door, directing the spray to all areas of the room while keeping about 1 metre from walls, fabrics and furniture. For fast knockdown, spray directly at flying insects. Do not remain in treated area. Keep room closed for 15 minutes. Ventilate room thoroughly before re-entry. It is recommended to check for potential staining and damage in an inconspicuous place before treating a large area. Do not use in food handling, storage or preparation areas while food is present.
