Plant growth stops when plant cell contents mix together causing brown necrotic plant tissue. Provides control and rapid burn down suppression of annual and perennial broadleaf and grass weeds, such as (but not limited to): algae, carpetweed, crabgrass, burning nettle, lichens, liverworts, morning glory, mosses and pigweeds (amaranths). Use in flower gardens, landscaped areas, around and on buildings, sidewalks, fences, bark mulch, driveways, patios and gravel.

GENERAL INFORMATION:

Spray only undesirable plant growth. Do not allow spray to contact any green parts of desirable plants. To ensure satisfactory control, plant leaves must be thoroughly and uniformly covered with the spray solution. This product works best during warm, dry conditions, but also works in cold weather. Application in cold conditions may delay appearance of plant damage. Product efficacy may be reduced when conditions are unfavourable to weed growth or when plants are mature. Will not migrate through soil. Does not translocate in plants. Does not provide residual weed control in soil or affect germinating weed seeds. **Treated surfaces may be slippery when wet.**

DIRECTIONS FOR USE:

WEEDS: Use a coarse nozzle setting to reduce drift. Thorough coverage is extremely important. Avoid spraying desirable plants. For spot treatment of individual weeds, spray the centre of plant to the point of runoff. Best results are obtained with young, actively growing weeds, less than 12 cm (4.7 in) high. If rain falls within three hours of treatment, an additional treatment may be required. Plant damage will be visible from a few hours to two days after treatment. Repeat application every two to three weeks to control new weeds growing from seed and re-growth from biennial and perennial weeds. Thoroughly clean equipment after use.

MOSSES, ALGAE, LIVERWORTS AND LICHENS: Use a coarse nozzle setting to reduce drift. Spray moss and algae thoroughly as complete coverage is extremely important. Avoid spraying desirable plants. DO NOT apply to moss or algae in lawns. Plant damage will be visible from within a few hours to two days after treatment. For mosses, algae, liverworts and lichens, one application may last up to one year. Repeat treatment if re-growth occurs. Thoroughly clean equipment after use.

REFILL INSTRUCTIONS: Use as a refill for an empty container of WILSON[®] ULTRA TOTAL WIPEOUT[®] BATTERY POWERED (Reg. No. 31792 P.C.P. Act). DO NOT transfer or dilute the solution. Remove the sprayer from the original empty bottle and attach to the refill container by following these steps:

- 1. Remove cap, battery sprayer and holder from original bottle.
- 2. Remove cap from refill bottle.
- 3. Place holder, battery sprayer and cap onto refill bottle and tighten cap.

HOW TO USE SPRAYER:

- A. Aim toward target and away from people and pets.
- B. Press the trigger to spray.
- C. Release the trigger to stop spray.

After use:

- 1. Twist nozzle completely to CLOSE position.
- 2. Secure sprayer upright in holder.
- 3. Failure to adjust nozzle completely to CLOSE position and properly secure sprayer in holder may result in leakage and damage to property or injury to people or animals.

To replace batteries:

- 1. Slide battery compartment door to unlatch and open.
- 2. Remove used batteries and insert new AA batteries *in correct positions* as marked per diagram inside of battery compartment. Never insert the positive end where the negative end belongs and vice versa. Always use a complete set of new batteries of the same type when replacing batteries. *Never* mix alkaline, carbon-zinc or rechargeable batteries.
- 3. Securely close battery compartment door.
- 4. Always follow manufacturer's recommendations for use and disposal of batteries.

Additional Operating Notes:

- Do not submerge in water.
- Before each use, inspect sprayer carefully. Make sure hose is flexible and not kinked, worn or cracked, and that all connections are tight.
- When storing sprayer for prolonged periods remove batteries.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. May irritate eyes. Avoid contact with eyes. Use only in well ventilated areas. For good hygiene practice, wear gloves when handling this product. Avoid direct application to ponds, streams and lakes. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

FIRST AID: If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. DISPOSAL: The sprayer is reusable only with WILSON® ULTRA TOTAL WIPEOUT® BATTERY POWERED REFILL (Reg. No. 32079). Do not refill the container with any product. Remove used batteries from the sprayer and dispose of accordingly. Recycle empty container.
