WeedOut® Ultra Professional provides control of dandelion and plantain and top growth control of fall hawkbit, hawkweed, cinquefoil, and black medic in turf. Visible effects on weeds can be observed within 24 hours and weeds die in four to eight weeks.

This product can be applied to small patches and individual broadleaf weeds as a spot treatment. To maximize its effectiveness, this herbicide should be used in conjunction with a sound turf maintenance program. Avoid mowing the lawn until the effect of weed treatment is visible.

DIRECTIONS FOR USE: SHAKE WELL BEFORE USING.

- Mix one part of **WeedOut® Ultra Professional** with 9 parts of water.
- Treat broadleaf weeds in lawns and turf (on right-of-ways, non-crop areas, golf courses, sod production, parks, cemeteries and athletic fields) when weeds are actively growing.
- **For spot treatment only.** Use any standard hand-held or backpack sprayer.
- Use coarse nozzle setting to reduce drift.
- Avoid over applying to the point of runoff.
- Do not apply to drought stressed grass or newly seeded grass.
- Do not apply in very hot or rainy weather, or if rainfall is forecast within the next 2 to 4 hours.
- Do not water for 2 hours after application. For more resistant weeds, re-apply after 4-6 weeks.

This product will not prevent new weeds - **apply only when weeds are present.** Grass that is accidentally treated may temporarily become brown but will recover.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Wear safety goggles, chemical resistant gloves, long pants and long-sleeved shirt, with shoes and socks during mixing, loading, application, clean-ups, and repairs. Wash hands thoroughly with soap and water before eating, drinking or smoking. Remove protective equipment immediately after handling, wash thoroughly and change into clean clothing. Avoid any activities that could result in skin contact with treated lawns or turf surfaces until residues have dried. Toxic to terrestrial and aquatic plants. Do not apply to desirable plants. As this product is not registered for the control of pests in aquatic systems, **DO NOT** use to control aquatic pests. **DO NOT** contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Do not apply when winds are gusty.

FIRST AID: If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. STORAGE: Store unused product in original container away from children and direct sunlight. Do not store spray mixture in sprayer for prolonged periods. **KEEP FROM FREEZING.**

DISPOSAL:
