DIRECTIONS: Shake well. Repels mosquitoes for 5 hours. Also repels black flies, biting midges, deer flies, stable flies, ticks, and chiggers. Apply sparingly not under clothing and only when necessary. Reapply after hours if necessary. Spray clothing and exposed skin except face. **TO APPLY TO FACE:** Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat or store at temperatures over 50C. Do not spray near open flame or spark, or while smoking. Causes eye irritation. DO NOT get in eyes. Avoid contact with mouth. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.
