Glyphosate is not to be applied using hand-wicking or hand-daubing methods.

Use this product as a refill for empty containers of Roundup® Ready-to-Use Tough Brush & Poison Ivy Control with Wand Applicator, PCP# 31997. DO NOT add water.

Use the applicator from the empty bottle to connect to this refill:

1. [Flip up spout on refill bottle./Flip up spout until fully upright./Twist [spout/knob] to "ON"/Pull spout up.]
2. Insert hose connector from applicator handle into [spout/knob/opening] on cap until it "clicks" in place.
3. Adjust spray nozzle to desired spray pattern.

4. Aim sprayer nozzle at centre of weed and spray to wet.
5. Storage: After use, [close spout on cap./flip spout down to the "flat" position to close./close spout on cap./twist [spout/knob] to "OFF"./push spout down.] No need to disconnect sprayer hose from cap. Close nozzle on applicator.

HOW TO APPLY:

- Spray the weeds or grasses you want to eliminate until thoroughly covered.
- For best results ensure that Refill for Roundup® Ready-to-Use Tough Brush & Poison Ivy Control with Wand Applicator gets down to the roots - avoid tillage or disturbing the treated area for 7-10 days. This will ensure that the entire plant, including the root, is eliminated.
- Avoid spray contact on desirable plants as any plant contacted may be killed. When spot treating around desirable plants, shield plants from drift with a piece of cardboard or plastic. If a desirable plant is accidentally sprayed, rinse off immediately with water.
- Do not apply to the point of run off.

WHERE TO APPLY:

IMPORTANT: Do not spray plants or grasses you like - they may die too. Not recommended for spot weed control in lawns since Refill for Roundup® Ready-to-Use Tough Brush & Poison Ivy Control with Wand Applicator kills lawn grasses.

- **Brush control:** Apply after leaves are fully expanded. Treat trees and brush up to 1.5 m in height only; for taller plants cut down and spray regrowth.
- **Poison ivy:** Apply to vigorously growing plants. Apply after seed heads, flowers or berries appear.
- **For lawn and garden renovation,** skip one mowing prior to treatment. Allow at least 3 days after treatment before disturbing the soil and/or replanting.

Do not apply to the point of run off.

WHEN TO APPLY:

- Apply when weeds and grass are actively growing. Apply to annual weeds anytime after emergence. For perennial weeds apply after seed heads, flowers or berries appear.
- For best results, apply during warm, sunny weather (above 15°C) to accelerate systemic movement from foliage to roots.
- Apply when air is calm to prevent drift to desirable plants.

- Do not apply if rainfall is forecast for the time of application. Rain-Proof - Rain or watering two hours after application will not wash away effectiveness. However, heavy rainfall immediately after application may wash the chemical off the foliage and repeat treatment may be required.
- All ornamental flowers, trees & shrubs may be planted **1 day after** application.

WHAT TO LOOK FOR:

- Visible symptoms of control, such as browning or yellowing of leaves, will occur within 1 to 2 days with complete control in 7 to 10 days.

HOW IT WORKS:

- Refill for Roundup® Ready-to-Use Tough Brush & Poison Ivy Control with Wand Applicator is a non-selective vegetation control herbicide which controls brush and poison ivy, as well as most annual and perennial grasses, including lawn grasses & broadleaf weeds (i.e. virtually anything that is green and growing). Refill for Roundup® Ready-to-Use Tough Brush & Poison Ivy Control with Wand Applicator enters plants through foliage and moves systemically to the roots, eliminating weeds by stopping the production of a substance found only in plants.
- **NOTE:** Refill for Roundup® Ready-to-Use Tough Brush & Poison Ivy Control with Wand Applicator has no soil activity and will not leach or run off to affect nearby vegetation. Controls only growing or emerged grasses and weeds. Repeat applications will be required as new seedlings and vegetation emerge.

PRECAUTIONS:

CAUTION: EYE IRRITANT. HARMFUL IF SWALLOWED. Avoid contact with eyes or prolonged contact with skin. Wear rubber gloves while handling. Do not allow others such as children and pets on treatment area during application or to re-enter treated areas until spray has dried. Wash immediately after using this product. FIRST AID:
