PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Causes eye irritation. DO NOT get in eyes. Wear protective eyewear. DO NOT wear contact lenses. May be harmful if inhaled. DO NOT breathe dust. FIRST AID:

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DIRECTIONS FOR USE: To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*.
