DIRECTIONS FOR USE:

How to apply: SHAKE CAN WELL BEFORE USING. Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will vaporize into cracks and crevices for insect control. Apply only as an indoor crack and crevice or indoor or outdoor spot treatment. For all uses on this label, DO NOT exceed 3 seconds per m². DO NOT APPLY AS A SPACE SPRAY, PERIMETER OR BROADCAST TREATMENT. OUTDOOR USE:

To control ants, brown dog ticks, cockroaches, crickets, earwigs, fleas, millipedes, sowbugs and spiders, and to kill house flies and cluster flies: For use as a spot treatment only on the exterior surfaces of buildings, garbage cans and on porches, patios and decks. Apply to the outside surfaces of foundations, around light fixtures and places where listed pests enter (e.g., screens, door frames, window frames). House flies and cluster flies will be killed when they land and crawl

on the treated surfaces. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.
