Also repels, black flies, deer flies, stable flies, ticks, biting midges and chiggers. Apply sparingly not under clothing and only when necessary. Reapply after 6 hours if necessary. Hold container upright and spray clothing and exposed skin except face. TO APPLY TO FACE: Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. CONTENTS UNDER PRESSURE. Do not place in hot water or near radiators, stoves or other sources of heat. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If irritation or other adverse effects develop, wash with soap and water immediately. Seek medical attention if symptoms persist.
