**DIRECTIONS FOR USE:**

**INDOOR USE:** Close doors and windows. Spray upwards in the air, directing spray into the corners of the room. Insects must be contacted to be killed. Work backwards toward exit. Keep room closed for 15 minutes, then ventilate. Keep spray at least 1 m from interior walls, fabrics and furniture. Repeat treatment on a weekly schedule, until insects have disappeared

**OUTDOOR USE:** Direct mist upwards in sweeping motions to all areas where insects are congregating such as porches, garages, storage areas, barns, under eaves, and around windows & doors, domestic kennels, domestic farms, and domestic stables. Insects must be contacted to be killed.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Avoid breathing spray mist. Avoid contact with skin, eyes and clothing. Harmful if swallowed, inhaled or absorbed through skin. Not for use on humans. Wash after use. In homes or dwellings, remove or cover all exposed foods and cooking utensils before spraying. Cover or remove aquaria and remove pets for 1 hour. Vacate room after treatment and ventilate before reoccupying. Wash contaminated clothing before reuse. Do not contaminate feed, food, litter or food-handling equipment. Do not use in areas where beekeeping equipment or supplies are stored, or where milk is stored or processed. Keep from freezing. CONTENTS UNDER PRESSURE. Do not place in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate can or store at temperatures over 50°C.

**STORAGE:** Store away from feed and food.

**ENVIRONMENTAL HAZARDS:** Do not contaminate any body of water. Highly toxic to crabs, fish and shrimp. Harmful to wildlife, if allowed to contaminate lakes and streams.

**FIRST AID:** **If in eyes**, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If on skin or clothing**, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. **If swallowed**, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. **If inhaled**, move person to fresh air. If person is not breathing, call 911 or an ambulance. Then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**DISPOSAL:** Do not reuse empty container. Discard empty container with household garbage.
