### DIRECTIONS FOR USE

DO NOT apply indoors as a broadcast application. ONLY spot or crack and crevice applications are permitted indoors in residential areas. Spot application is localized to a surface area not more than 0.2 m<sup>2</sup>. Spots are not to be adjoining. The combined area of spots is not to exceed 10% of the total surface area of the surface being treated. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

- DO NOT apply to any body of water.
- DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.
- Avoid application of this product when winds are gusty.
- DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed.
- DO NOT use in food handling, storage, or preparation areas while food is present.
- DO NOT apply when people, pets or livestock are present.
- DO NOT allow people, pets or livestock to enter treated areas until sprays have dried.
- DO NOT allow spray to drip or allow drift onto non-target surfaces.
- DO NOT apply to people, pets, livestock or sources of electricity
- DO NOT apply to furniture, mattresses, linens, toys or clothing.
- DO NOT apply to overhead areas or in confined spaces (for example, attics, crawlspaces).
- Ventilate treated areas after application by opening windows and doors or using fans where required to aid in the circulation of air.
- DO NOT apply as a space spray.
- When used outdoors on the exterior surfaces of buildings, porches, patios and decks, DO NOT treat soil, turf or other plants adjacent to the structure.
- Vinyl and Aluminum Siding: The application of this product to vinyl and aluminum siding (particularly lightly coloured, aged, weathered or otherwise damaged) may result in staining, bleaching or discoloration. Factors such as extreme heat and direct sunlight can promote damage. Before applying to vinyl or aluminum siding, treat a small area and evaluate 30 minutes later to allow any potential staining to occur. Regardless of the test results, do not apply to vinyl or aluminum siding while exposed to direct sunlight or during the heat of the day.

SHAKE WELL BEFORE USE. Hold container upright.

FOR USE INDOORS AND OUTDOORS ON THE EXTERIOR SURFACES OF BUILDINGS AND PORCHES, PATIOS AND DECKS TO KILL LISTED PESTS

Do not use tetramethrin in food handling, storage or preparation areas while food is present. Use only for spot or crack and crevice applications.

### FOR INDOOR USE:

To Kill Ants, Carpet Beetles, Cockroaches, Crickets, Earwigs, Silverfish, Sow bugs and Spiders: Spray areas where these pests are found or may hide, including dark corners or rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators, and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

To Kill Brown Dog Ticks and Fleas: Apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. DO NOT SPRAY PETS WITH THIS PRODUCT. For effective flea and tick control, treatment of the pet must be combined with the cleanup and sanitation of any area used by the pet. Vacuum floors, carpets, furniture, etc. (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding area. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

# FOR OUTDOOR USE ON THE EXTERIOR SURFACES OF BUILDINGS, PORCHES, PATIOS AND DECKS:

To Kill Flies and Mosquitoes: Use only out of doors as a spot treatment to aid in reducing annoyance from these insects. Spray outside surfaces of window and door-frames. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

#### PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN AND PETS. Avoid contact with eyes, skin and clothing. Harmful if swallowed. May cause eye or skin irritation. Do not inhale vapors. Wash well after handling and before eating, drinking and smoking. Wash contaminated clothing with soap and hot water before reuse. Do not wear contaminated shoes.

Remove animals for a minimum of 1 hour when spraying room. Following treatment, ventilate all rooms, do not access for a minimum of 15 minutes and do not re-enter before ventilation is complete. Avoid contact with treated surfaces until dry.

## FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
