To be used only in the manufacture (formulating, repackaging, repouring) of a pest control product solely for export from Canada. Read Technical Bulletin for formulating details.

First Aid:

If swallowed: Rinse mouth and throat with copious amounts of water. Do not induce vomiting.

If on skin/clothing: Take off contaminated clothing. Wash with plenty of soap and water.

If inhaled: Move to fresh air.

If in eyes: Hold eye open and rinse slowly and gently with water. Remove contact lenses, if present, then continue rinsing the eye.

Keep product in original container during storage and keep container lid tightly closed when not in use. This product should be used within 12 months of the date of manufacture under refrigerated conditions.
