**DIRECTIONS FOR USE:** For formulation into end-use products with a 0.01% (S)-methoprene concentration intended to be used in animal food processing or manufactured products, and animal food or feed containers or dispensers, such as Altosid Beef Cattle Mineral.

**FORMULATING INSTRUCTIONS:**

After the addition of the liquid components, add the **Altosid 2% MUP**, and blend to homogeneity. In formulations containing only dry components, add the **Altosid 2% MUP** last, and blend to homogeneity.

**PRECAUTIONS:** PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Wash thoroughly with soap and water after handling product and before eating, drinking or smoking. Wash contaminated clothing with soap and water before reuse. Do not wear contaminated shoes. Permits may be required for discharges containing this pesticide into lakes, ponds, streams or public waters. DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

**FIRST AID TREATMENT:**

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice.

Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
