CONTROLS ANTS, BROWN DOG TICKS, CARPET BEETLES, CLOTHES MOTHS, COCKROACHES, CRICKETS, EARWIGS, FIREBRATS, FLEAS, HOUSE FLIES, RED FLOWER BEETLES, RICE WEEVILS, SILVERFISH, SOWBUGS, SPIDERS - ALSO KILLS BEDBUGS.

DIRECTIONS: Apply directly to pests if possible. Hold container in any position while spraying, even upside down. Use for spot, crack or crevice application. Do not use as a space spray or broadcast application. Repeat application if pests continue to be a problem.

INDOOR USE: Spray hiding places including cracks, crevices, baseboards, openings around sinks, drains and pipes, behind stoves and refrigerators, around window frames, in localized areas of attics and basements and around interior foundations. **Ants** - Spray trails, nest and points of entry. **Fleas (adult and larvae)** - Thoroughly spray infested areas, pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, moldings, window and doorframes. Let dry thoroughly before allowing pets to contact treatment areas. Place fresh bedding in animal quarters following treatment. **Bed Bugs** - Spray directly into cracks and crevices where these pests are found or may hide along and behind baseboards, moldings and floors underneath objects such as the bed and nightstand. Take beds apart, spray all joints. Repeat as required.

OUTDOOR USE: Spray outside surfaces of screens, doors, window frames, foundations, eave troughs, under eaves, patios, light fixtures and other places where insects may congregate on or enter the structure. Application to vinyl and aluminum siding (particularly lightly colored, aged, weathered or otherwise damaged) may result in staining, bleaching or discoloration. Factors such as extreme heat and direct sunlight can promote damage. Always pre-test a small inconspicuous area to be treated, for colour fastness and staining. Pre-test siding. Evaluate 30 minutes after test application for potential staining. Never apply to vinyl or aluminum siding while exposed to direct sunlight or during the heat of day. Do not apply to tapestries, wall paper or similar materials that may stain.

HOUSE FLIES (indoor / outdoor): Spot treatment only. Flies will be killed when they land on the treated surfaces.

PRECAUTIONS: Wash hands after use. Do not use on humans or animals. Do not use in areas where food is handled, prepared or stored. After use and at least one hour drying time, wash all surfaces that may contact food. Remove pets, birds and cover fish aquariums before spraying. Do not allow people or pets to contact treated areas until surfaces are dry. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat or store at temperatures over 50°C. This product is extremely toxic to fish and aquatic invertebrates. Do not apply directly to lakes, rivers, streams, ponds, tidal marshes and estuaries. Do not contaminate the above mentioned aquatic areas through spray drift, cleaning of equipment or disposal of waste.

FIRST AID: If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If swallowed,** call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Have person sip a glass of water if able to swallow. Do not give anything by mouth to an unconscious person. **If inhaled,** move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take

container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: Do not reuse empty container. When container is empty, press valve to release all remaining pressure. Do not puncture or incinerate. Container is recyclable where programs or facilities exist. Refer to local municipal hazardous waste program for disposal of unused product. If recycling is not available, wrap empty container and discard in household garbage.
