**DIRECTIONS FOR USE**: SHAKE CAN WELL BEFORE USING. This product is designed for applying into cracks, crevices, or tight areas that are difficult to reach. The foaming action of this formula completely fills tight crevices leaving an insecticidal active residue. To enhance effectiveness of this product, apply directly to ants where possible. Remove protective cap and insert the extension tube into the spray nozzle before using. For all uses on this label, **DO NOT** exceed 7 seconds per m<sup>2</sup>. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

USE LIMITATIONS FOR ALL USES: DO NOT apply when people or pets are present. DO NOT allow people or pets to enter treated areas until sprays have dried. DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash following treatment. Any food/feed accidentally contaminated with spray solution must be discarded.DO NOT allow spray to drip or allow drift onto non-target surfaces. DO NOT apply to people, animals or sources of electricity. When applied indoors: Ventilate treated areas after application by opening windows and doors or using fans, where required, to aid in the circulation of air. **INDOOR USE AT BUILDINGS:** Apply as an indoor crack and crevice treatment only. **DO NOT** APPLY AS A SPACE SPRAY, PERIMETER OR BROADCAST TREATMENT. <u>Crack and crevice</u> is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings. Good sanitary practices should be maintained to prevent re-infestation. **DO NOT** spray product in areas where it can be mopped away.

**To control ants**: Thoroughly treat indoor building surfaces including cracks and crevices in walls, floors and ceilings, along and behind baseboards; around water pipes and tanks; walls behind and floors beneath appliances (e.g., refrigerators and stoves) and furniture (e.g., drawers, cabinets and storage units); around sinks, drains and pipes; around interior foundations; garbage cans; localized areas of floors and floor coverings; and points of entry (e.g., around windows and doors). **DO NOT** apply to furniture, mattresses, linens, toys or clothing. Provide adequate ventilation after indoor use. KEEP PETS AND CHILDREN AWAY FROM SURFACE UNTIL DRY. DO NOT use in areas where food is processed, handled, served or stored.

**OUTDOOR USE ON ANT HILLS: To control ants:** Gently insert the extension tube as far as possible into cracks and crevices in driveways, patios, sidewalks, or interlocking brick where ants hide. Depress trigger and allow foam to fill the area. Stop spraying when the foam comes back out the crack or crevice. For best results, treat all cracks and crevices in the area where ants are found.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed, inhaled or absorbed through skin. Avoid contact with eyes, skin, or clothing. May cause skin and/or eye irritation. Contents under pressure. **DO NOT** place in hot water or near radiators, stove or other sources of heat.

**ENVIRONMENTAL PRECAUTIONS:** Toxic to aquatic organisms, birds, bees and beneficial arthropods (which may include predatory and parasitic insects, spiders and mites). Minimize exposure to non-target areas. Avoid application around blooming plants.
