### DIRECTIONS FOR USE

Bed Bugs.

Before application, shake container for a few seconds, then spray a thin even layer of DX13 Pro onto surface to be treated. Make applications in such a manner as to avoid deposits on exposed surfaces or introducing the material into the air. Take beds apart. Apply to cracks, crevices and voids associated with the mattresses, boxsprings, bedframe and other furniture where these insects may harbour, travel, breed or enter the room. Treat mattresses, especially around seams, tufts, folds and edges. Cover with clean bedding before using. Bed bugs may also harbour in areas of the room away from the bed or furniture. Spray directly into wall voids, behind wall hangings, floor molding, window casings, carpet edge, and other cracks and crevices or voids. Apply directly to the bed bug if possible. Repeat as required.

## PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Do not use in presence of open flame or spark or while smoking. CONTENTS UNDER PRESSURE. Container may explode if heated. Do not expose to temperature above 50°C /122°F.

Avoid breathing dust and vapours. Avoid contact with eyes, skin or clothing.

Wear a suitable dust mask approved by NIOSH when handling.

For applications when using a dust blower, wear a full-face NIOSH approved respirator during loading and application.

Wash hands after application and clean-up activities.

Unprotected personnel should not enter the area, during application or subsequent clean-up. Use adequate ventilation when handling, during application, and clean-up activities. Use appropriate eyewear when handling, during application, and clean-up activities. When used indoors in commercial or industrial settings, do not apply in the immediate vicinity of people or pets.

#### DISPOSAL:

When container is empty, press the valve to release all remaining pressure, then dispose of the empty container in accordance with provincial requirements. Do not puncture or incinerate. For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for information on the clean-up of spills.

### FIRST AID

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.
