## FIRST AID

**If on skin or clothing**, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**If in eyes**, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If swallowed**, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If inhaled**, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

## DIRECTIONS FOR USE

To be used only in the manufacture of a herbicide which is registered under the *Pest Control Products Act*.

## STORAGE

DO NOT contaminate water, food and feed by storage, cleaning of equipment or disposal.

Keep in original container during storage.

Keep container tightly closed.

## **DISPOSAL**

Completely empty container by shaking and tapping sides and bottom to loosen clinging particles.

Empty residue into formulation equipment.
