PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. May cause sensitization. Avoid contact with eyes, skin or clothing. Avoid inhaling/breathing dust. Wear a long-sleeved shirt, long pants, shoes plus socks, water-proof gloves and NIOSH approved particulate filtering facepiece respirator with any N, R or P filter when handling and during all clean-up and repair activities. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Treat symptomatically.

STORAGE:

To prevent contamination, store this product away from food or feed. Store in a dry area inaccessible to children. Store in a cool, dry place. Store in original container only. Keep container closed when not in use. *Bacillus velezensis* strain RTI301 Technical should be used within 24 months from the date of manufacture when stored at 25°C.
