Section 8: Resistance Management

Resistance Management Recommendations:

For resistance management, **Maxunitech Prothioconazole 480SC** contains a Group 3 fungicide. Any fungal population may contain individuals naturally resistant to Maxunitech Prothioconazole 480SC and other Group 3

fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same fields. Other resistance mechanisms that are not linked to site of action but specific for individual chemicals, such as enhanced metabolism, may also exist.

Appropriate resistance-management strategies should be followed.

To delay fungicide resistance:

- Alternate with fungicides having a different mode of action other than Group 3 every 7 to 10 days after each application of **Maxunitech Prothioconazole 480SC**.
- Do not apply more than the indicated maximum number of applications per year specified for each crop in the DIRECTIONS FOR USE, Section 7 table.
- Use tank mixtures with fungicides from a different group that is effective on the target pathogen when such use is permitted.
- Fungicide use should be based on an integrated disease management program that includes scouting, historical information related to pesticide use and crop rotation and considers host plant resistance, impact of environmental conditions on disease development, disease thresholds, as well as cultural, biological and other chemical control practices.

Section 9: Application Precautions

GROUND APPLICATION:

- 1. Use well-maintained and calibrated conventional spray equipment, which provides adequate and uniform coverage.
- 2. Apply Maxunitech Prothioconazole 480SC in a minimum of 100 L water/ha, unless otherwise specified in DIRECTIONS FOR USE, Section 7.
- 3. Spray screens should be no finer than 50 mesh.
- 4. Ensure that the by-pass line discharges at the bottom of the tank to minimize foaming.
- 5. Maintain pressure at no less than 275 kPa to ensure good foliage penetration and coverage.
- 6. Provincial spray buffer zones that are greater than the spray buffer zones indicated in the DIRECTIONS FOR USE, Section 7, should be respected.
- 7. If spray mixture remains in the tank overnight, or for long periods during the day, agitate thoroughly prior to application.

AERIAL APPLICATION-GENERAL INFORMATION:

- Apply only by fixed-wing or rotary aircraft equipment, which has been functionally and operationally calibrated for the atmospheric conditions of the area and the application rates and conditions of this label.
- Label rates, conditions and precautions are product specific. Read and understand the entire label before opening this product. Apply only at the rate recommended for aerial application on this label. Mixing Instructions:

Maxunitech Prothioconazole 480SC must be applied with properly calibrated, clean equipment. Prior to adding Maxunitech Prothioconazole 480SC to the spray tank, ensure that the spray tank is thoroughly clean.

Maxunitech Prothioconazole 480SC applied alone:

- 1. Add one-half of the required amount of water to the spray or mixing tank and start agitation.
- 2. Add the required quantity of **Maxunitech Prothioconazole 480SC** to the water and complete filling with water to the required total volume.
- 3. Maintain agitation throughout mixing and spraying.
- 4. Maxunitech Prothioconazole 480SC should be thoroughly dispersed prior to the addition of a non-ionic surfactant. Maxunitech Prothioconazole 480SC is recommended to be used with a registered non-ionic surfactant, such as Agral 90 or AgSurf, at 0.125% vol/vol.
