**PRECAUTIONS:**

KEEP OUT OF REACH OF CHILDREN AND PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

**FIRST AID:**

If Swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

In Case of Eye Contact: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If Inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, and then give artificial respiration, preferably by mouth-to-mouth. Call a poison control centre or doctor for further treatment advice.

In Case of Contact with Skin or Clothing: Remove contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:**

Treat symptomatically.

**DECONTAMINATION AND DISPOSAL:**

For spills, wear appropriate safety equipment. Absorb spilled product with inert substance such as sawdust or sand. Wash spill area with detergent solution.

Do not contaminate irrigation water, lakes, streams or ponds by cleaning of equipment or disposal of wastes.

If involved in fire, use water, fog, foam CO<sub>2</sub> or a dry chemical extinguishing media. Noxious fumes may be produced under fire conditions; wear self-contained breathing apparatus. Prevent water used in fire fighting from entering public water supplies.
