#### **PRECAUTIONS**

KEEP OUT OF REACH OF CHILDREN. Severely irritating to the eye. DO NOT get in eyes. May irritate the skin. Avoid contact with skin. Avoid breathing mist. #### **FIRST AID**

This product may cause injury to other plants if not mixed and applied properly. Follow instructions for mixing and applying carefully.

To reduce runoff from treated areas into aquatic habitats avoid application to areas with a moderate to steep slope, compacted soil, or clay.

To ensure efficiency, postpone application if possible when heavy rain is forecast.

Contamination of aquatic areas as a result of runoff may be reduced by including a vegetative filter strip between the treated area and the edge of the water body.

# **DIRECTIONS FOR USE**

Shake well before use. Foliar treatment for crops listed below.

Application use directions: Within the stated rate and interval ranges, use the higher rate and shorter application intervals under conditions conducive to moderate to high disease pressure. Apply in sufficient volume to ensure full coverage for effective control. Both sides of leaves should be covered with the product. Use nozzles that will provide excellent coverage of the plant foliage (ex: hollow cone nozzle). The spray quality should be very fine. Begin applications when conditions are conducive to disease development or at first sign of disease.

**Surfactant**: Use of spreader surfactant can help achieve better coverage of leaves and better efficacy. Suggested non inonic spreader surfactants: Agral 90 or Ag Surf at 0.1% (v/v) or silicone surfactant (Xiameter OFX-0309 Fluid at 0.05% (v/v).

**Angular leaf spot cautions:** Do not use silicone-based surfactant (e.g. Xiameter OFX-0309 Fluid) when the angular leaf spot is active as this type of surfactant can reduce efficacy against the disease when it is visible and active (water-soaked spots). If angular leaf spot is not active (spots are dry or not visible), Tivano Plus can be used for powdery mildew with the addition of Xiameter surfactant.

The pre-harvest interval (PHI) is 0 (zero) days.

#### **STORAGE**
