Fatal or Poisonous if swallowed. Harmful if inhaled. Avoid inhaling/breathing dusts, fumes, and vapours. CORROSIVE to the eyes and skin. DO NOT get in eyes or skin. Potential skin sensitizer.

It is recommended to wear rubber gloves and goggles when handling. Users should wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Always store this product out of reach of children and pets and away from food and beverages.

Dangerous gas formed when mixed with acid. DO NOT mix with any other chemical. Strong oxidizing agent. May cause fire or explosion if contaminated. DO NOT let product get wet or damp before using. DO NOT mix product in a small amount of water before using.

FIRST AID:

If swallowed: Call a poison control centre or doctor IMMEDIATELY for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for further treatment advice.

WHY USE THIS PRODUCT: This multi-functional sanitizer is a slow dissolving tablet that kills bacteria, kills and prevents algae, destroys organic contaminants**, clarifies water, enhances filtration, is stabilized for sunlight protection, and is formulated to kill algae associated with high heat, warm weather and heavy rain.

DIRECTIONS FOR USE: Read entire label and use strictly in accordance with precautionary statements and directions. T-0035 is for use only in feeders, [or] floaters, [or] skimmers, [or] automatic chlorinators].

For outdoor pools, chlorine residuals can be protected from destruction by the sun's rays by adding 300 g of stabilizer (cyanuric acid) per 10,000 L of pool water to yield the required initial concentration of 30 ppm.

Test and balance water prior to use following recommended levels below:

Free available chlorine:	1.0 – 3.0 ppm
pH:	7.2 – 7.8
Total Alkalinity:	100 – 120 ppm
Calcium Hardness:	200 – 300 ppm

Periodic superchlorination of pool water is recommended. Follow label instructions of superchlorinating product being employed.

Use: Protects against algae and bacteria for water that stays clean, clear & free of visible algae.

Application Methods	
If water is cloudy or green, add a granular shock product per label directions.	
Feeder & Floater ¹	Fill with [tablets] [sticks] [pucks] and adjust output to bring chlorine to 1-3 ppm, test and refill as needed to maintain 1-3 ppm.
Skimmer ²	Add 1 [tablet] [stick] per 20,000 L to bring chlorine to 1-3 ppm then add more tablets as needed to maintain 1-3 ppm.
Do Not apply other chemicals through feeder, floater or skimmer as an explosion might occur. Direct contact with pool surfaces or equipment may cause damage.	

For best results: Add more product after heavy pool use, high temperatures or rain to maintain 1-3 ppm.

This product contains stabilizer which can accumulate in pool water. Keep stabilizer within the range of 30 - 100 ppm by dilution with fresh water.

¹ For use with 1" tablets, 3" pucks & sticks

² For use with 3" pucks & sticks

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

DO NOT apply this product in a way that will result in direct contact with adults, children or pets.

IMPORTANT NOTES:

1. Shock your pool every week and also after heavy rain or heavy use to help keep your pool water properly maintained.
2. Sunlight, rainfall, temperature, number of swimmers, and frequency of pool use affect the rate of chlorine residual loss. Adjust cleaning and chemical maintenance accordingly.
3. Use this product in an automatic feeder [or] floater, [or skimmer] designed for this product.
4. Do not add other chemicals into the feeder [or] floater [or skimmer] where this product is in use as a fire or explosion may occur.
5. Use this product in a skimmer only if the skimmer and the piping between skimmer and pump are plastic. In vinyl pools, do not leave the pump turned off for more than 8 hours when this product is in the skimmer. If the pump is off for more than 8 hours, bleaching and damage to liner may occur.
6. To avoid damage to pool surface or materials do not allow product to come in direct contact with these materials. Do not throw product directly into pool.

STORAGE: Keep product dry in tightly closed original container when not in use. Store in a cool, dry, well-ventilated area, away from heat, open flame, sunlight and other chemicals.

DISPOSAL: Rinse container thoroughly before discarding. Offer for recycling if available. Do not reuse empty container. For information on the disposal of unused, unwanted product, contact the Provincial Regulatory Agency or the manufacturer. Contact the manufacturer and the Provincial Regulatory Agency in case of a spill, and for clean-up of spills.

PHYSICAL AND CHEMICAL HAZARDS: Mix only with water. Use clean, dry utensils and equipment. Do not add this product to any dispensing device containing remnants of any other product. Such use may cause a violent reaction leading to fire and explosion.

ENVIRONMENTAL HAZARDS: This product is toxic to fish. Do not discharge where it will drain into lakes, streams, ponds or public waters.
