PERSONAL PROTECTIVE EQUIPMENT (PPE)

Wear chemical-resistant coveralls over a long-sleeved shirt, long pants, chemical-resistant gloves, socks, chemical-resistant footwear and a respirator with a NIOSH-approved organic vapour-removing cartridge with a prefilter approved for pesticides, or a NIOSH-approved canister approved for pesticides, during mixing and loading, clean-up and repair.

This pesticide is toxic to fish and aquatic invertebrates. Do not discharge effluent containing this product into lakes, ponds, streams, estuaries, oceans or public waters. Plastiguard 642 VP provides fungal protection for flexible PVC, thermoplastic elastomers and rubbers used to manufacture roof membranes, pool liners, pool deck liners and geomembranes. Its spectrum of activity helps in the prevention of surface growth, permanent staining, embrittlement and premature product failure. It can be incorporated into the formulation during mixing or compounding processes. It must be added earlier than the remaining additives in the blending operation to ensure a homogeneous dispersion. Use at levels of 1.0% - 3.0% based on the total formula weight.

It is recommended that the biocide Plastiguard 642 VP be purged from the equipment prior to shutdown and cleanout.

For the optimum biocide concentration and compatibility with individual formulations laboratory tests should be performed.

NOTICE FOR USER:

This pest control product is to be used only in accordance with the directions on the label. It is an offense under the *Pest Control Products Act* to use this product in a way that is inconsistent with the directions on the label.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Do not store above 104°F (40°C). Keep container tightly closed when not in use. Do not store with strong oxidizing agents.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Non-refillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or dispose of in a sanitary landfill or incinerate, or if allowed by provincial and local authorities, by burning.
