## **DIRECTIONS FOR USE**

To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*.

### **PRECAUTIONS:**

#### **PREVENT ACCESS BY UNAUTHORIZED PERSONNEL**

Avoid contact with skin, eyes or clothing. Wash thoroughly after using or before eating, drinking or smoking. Wear clean protective clothing, including chemical resistant gloves, goggles and respirator when handling manufacturing product.

### **FIRST AID:**

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label, or product name and Pest Control Product Registration number with you when seeking medical attention.
