For use on residential, commercial, industrial and municipal lawns and turf (on rights of way, landscaping, non-crop areas, golf courses, parks, cemeteries and athletic fields) consisting of one or more of Kentucky bluegrass, perennial ryegrass, and fescue (tall fescue, chewings fescue, and/or creeping fescue) for the pre- and post-emergent control of dandelion (*Taraxacum officinale*), English daisy (*Bellis perennis*), false dandelion (*Hypochaeris radicata*), white clover (*Trifolium repens*), black medic (*Medicago lupulina*), bull thistle (*Cirsium vulgare*), Canada thistle (*Cirsium arvense*), common chickweed (*Stellaria media*), creeping buttercup (*Ranunculus repens*), slender speedwell (*Veronica filiformis*), narrow-leaved plantain (*Plantago lanceolata*), dove's-foot geranium (*Geranium molle*), wild geranium (*Geranium robertianum*), lawn burweed (*Soliva pterosperma*), moss and algae, and for the suppression of broad-leaved plantain (*Plantago major*). For pre-emergent control of crabgrass.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Avoid contact with skin, eyes or clothing. Wear a long-sleeved shirt, long pants, chemical-resistant gloves, and socks and shoes when applying the product and during all clean-up and repair activities. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove contaminated clothing and wash before reuse.

FIRST AID:

If swallowed:

Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing:

Hold eye open and rinse slowly and gently with water for 15 - 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

As this product is not registered for the control of pests in aquatic systems, DO NOT use to control aquatic pests.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

One kg of product will treat between 9 and 20 m² (97- 215 ft²). Ensure lawn is wet from dew or water lawn lightly before application if temperature is below 25°C. If temperature is above 25°C do not pre-wet grass and apply product in the late afternoon or evening. Any standard dry spreader may be used. Uniform coverage is important.

Repeat treatment every 21-28 days up to 4 times per area per year.

Visible signs of control may be seen within several hours after application. Susceptible weeds, moss or algae will turn brown or black. Occasionally a darkening of the grass leaf blades can occur after treatment, however the grass will recover within a few days to several weeks. May stain thatch (dead grass under lawn); this does not affect the health of the grass. If turf is damaged, irrigate 24 hours after application, followed by mowing to remove the turf tip burn can help lawn recover faster.

Use Precautions:

- Do not apply to drought stressed grass; ensure that the lawn is well watered prior to application.
- Do not apply to bentgrass. If unsure of grass sensitivity, test apply a small area of your lawn.
- Do not apply to newly seeded areas until four or more weeks after grass seedlings have emerged.

- Avoid applying to desirable plants. Any desirable plants or structures accidentally contacted should be rinsed immediately with water.
- Do not apply if rainfall is expected within 24 hours of application.
- Do not irrigate within 24 hours of application.
- Do not apply more than 4 times per area per year.

STORAGE: Store this product away from food or feed.

DISPOSAL

1. Thoroughly empty the contents of the container into the application device.
2. Follow provincial instruction for any required additional cleaning of the container prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
