PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN.

Corrosive to eyes. Severely irritating to the skin. Harmful if swallowed. POTENTIAL SKIN SENSITISER. Harmful if inhaled. Avoid inhaling sprays. Do not get in eyes, on skin or on clothing. Avoid contamination of food.

Wear coveralls over a long-sleeved shirt, long pants, chemical-resistant gloves, socks and chemical-resistant footwear during mixing, loading, application, clean-up and repair. In addition, wear protective eyewear (goggles or face shield) during mixing and loading.

Formaldehyde can be released during use of this product. Spillage

FIRST AID

DIRECTIONS FOR USE

Adhesives:

Add 500 g to 3000 g of Preventol P 91 MV to each 1000 kg of product (500 - 3000 ppm)

Paints and Coatings:

Add 500 g to 3500 g of Preventol P 91 MV to each 1000 kg of product (500 - 3500 ppm)

Polymer Latex Emulsions:

Add 500 g to 3800 g of Preventol P 91 MV to each 1000 kg of product (500 - 3800 ppm)

Building Materials (caulks, asphalt emusions, joint compounds):

Add 500 g to 2000 g of Preventol P 91 MV to each 1000 kg of product (500 - 2000 ppm)

Concrete Admixtures:

Add 500 g to 4000 g of Preventol P 91 MV to each 1000 kg of product (500 - 4000 ppm)
