PRECAUTIONS

May Irritate eyes. Avoid contact with eyes. Harmful if inhaled. Avoid inhaling/breathing dusts, sprays or vapours. Workers should wash hands before eating, drinking, chewing gum, using tobacco or the toilet. Remove personal protective equipment immediately after handling. As soon as possible, wash thoroughly and change into clean clothing.

FIRST AID

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

TOXICOLOGICAL INFORMATION

No specific antidote. Employ supportive care. Treatment should be based on judgment of the physician in response to reactions of the patient.

AGRICULTURAL CHEMICAL

Do not ship or store with food, feeds, drugs or clothing.

ENVIRONMENTAL PRECAUTIONS

Toxic to aquatic organisms and terrestrial plants. DO NOT discharge effluent containing the product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

STORAGE

Keep in original container during storage. Do not ship or store this product with foodstuffs, feed, seed, fertilizers, drugs or clothing. Store in a cool, dry well ventilated place. Keep away from fire or open flame, or other source of heat.
