To be used only in the manufacture of a pesticide registered under the *Pest Control Products Act*.

## **PRECAUTIONS**

### **PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.**

Strictly observe all precautions for handling and using pesticides. May irritate the skin. Avoid contact with skin, eyes and clothing. Do not contaminate food, feed or water supplies. ## **FIRST AID**

**If in Eyes:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

## **TOXICOLOGICAL INFORMATION**

There is no specific antidote, if this product is ingested. Treat symptomatically. If a large amount has been ingested and emesis is inadequate, lavage stomach.

An aqueous suspension of activated charcoal can be administered to absorb remaining toxicant.

## **STORAGE**

Store in original containers in a well-ventilated, cool, dry, and secure area. Ship and store away from food, feed or seed. Keep containers tightly closed.

## **DISPOSAL**
