DIRECTIONS FOR USE:

To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONEL. Do not swallow. Harmful if inhaled. Avoid inhaling/breathing mist or vapours. Causes eye and skin irritation. DO NOT get in eye or on skin. Potential skin sensitizer. Wash thoroughly with soap and water after handling. Individuals who are sensitive or allergic to garlic should avoid handling. DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Treat symptomatically.

STORAGE:

Store containers tightly closed, out of direct sunlight, at temperatures between 4° and 20° C. Cooler storage temperatures are preferred.

DISPOSAL:

Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal and provincial regulations. For additional details and clean up of spills, contact the manufacturer and the provincial regulatory agency.
