PRECAUTIONS

FIRST AID

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

Treat symptomatically.

STORAGE

Store product in original container only, away from food or feed. Not for use or storage in or around the house. Keep container closed. Keep in a separate freezer at -80°C.

Do not store longer than twelve months after date of manufacture.
