### PRECAUTIONS:

#### PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

Strictly observe all precautions for handling and using pesticides. May irritate eyes. May irritate skin. Potential skin sensitizer. Avoid contact with skin, eyes and clothing. Wear protective goggles when handling. **DO NOT** wear contact lenses while handling. Use of an approved pesticide respirator is recommended. ### **FIRST AID:**

There is no specific antidote. If this product is ingested, treat symptomatically.

### **ENVIRONMENTAL PRECAUTIONS:**

### STORAGE:
