DIRECTIONS FOR USE:

To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. May cause sensitization. Avoid contact with eyes, skin or clothing. Avoid inhaling/breathing aerosols. Wear a long-sleeved shirt, long pants, shoes plus socks, water-proof gloves and NIOSH approved respirator with any N, R, P or HE filter for biological products when handling, and during all clean-up and repair activities. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

STORAGE

Do not contaminate water, food, or feed by storage and disposal. Do not store this product near fertilizers, seeds, insecticides or fungicides. Do not store near heat or open flames. For safety and prevention of unauthorized use, all pesticides should be stored in locked facilities, inaccessible to children.
