PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN

May irritate skin. Severely irritating to the eye. Harmful if swallowed. Do not get in eyes or on clothing. Avoid contact with skin.

PERSONAL PROTECTIVE EQUIPMENT (PPE):

Wear a long-sleeved shirt, long pants, chemical-resistant gloves, socks and shoes, and protective eyewear (goggles or face shield) during mixing, loading, application, clean-up and repair.

Follow manufacturer's instructions for cleaning/maintaining PPE. If no such instructions exist for washables, use detergent and hot water. Keep and wash PPE separately from other laundry.

USER SAFETY RECOMMENDATIONS

Users should:

FIRST AID:

STORAGE:

This material has a tendency to crystallize at low temperatures. Storage temperatures below 32°C (90°F) and above 0°C (32°F) are suggested.

DISPOSAL:

GENERAL INFORMATION

PRODUCT: All application rates are given in percentage by weight and refer to the product Polyphase PW30, for in-can and dry-film preservation against fungi.

DIRECTIONS FOR USE: In order to determine the most cost-effective use level for Polyphase PW30 in a given use, field trials are suggested.

GENERAL PRECAUTIONS AND RESTRICTIONS

Do not apply this product in a way that will contact workers or other persons. Polyphase PW30 is not to be used in formulations for materials that come into contact with food.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

DO NOT discharge effluent containing this product or the biocide produced into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters unless the effluent has been detoxified by suitable means.

APPLICATION INSTRUCTIONS:

PAINTS AND COATINGS: Use 0.33–1.6%. For hot humid areas, use up to 2.67%. For interior paints, use 0.033–0.53%. For wood protective stains use 1.07–1.6% of Polyphase PW30.

ADHESIVES: Use 0.033–0.33%.

DISPERSED PIGMENTS: For use in the manufacture and storage of dispersed pigments, extender slurries, and colorants at 0.2%–0.27%.

NOTICE TO USER: This pest control product is to be used only in accordance with the directions on the label. It is an offense under the *Pest Control Products Act* to use this product in a way that is inconsistent with the directions on the label.
