DIRECTIONS FOR USE

To be used only in the manufacture of a pesticide which is registered under the *PEST CONTROL PRODUCTS ACT*.

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Harmful if swallowed. May irritate eyes. Avoid contact with eyes or prolonged contact with skin. Wash hands and face after handling and before eating or smoking. Wear long-sleeved coveralls over normal work clothing and chemical resistant gloves when handling product. This product is toxic to fish and other aquatic invertebrates. Do not contaminate food, feed, domestic or irrigation water supplies, lakes, streams and ponds.

DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries or other waters.

FIRST AID

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for further treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

ENVIRONMENTAL PRECAUTIONS

TOXICOLOGICAL INFORMATION

Treat symptomatically. Induce emesis or lavage stomach if a large amount of product has been ingested.

STORAGE
