## **DIRECTIONS FOR USE**

To be used only in the manufacture of a pesticide product which is registered under the *Pest Control Products Act*.

## **PRECAUTIONS**

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

May be harmful or fatal if inhaled. Avoid inhaling sprays or fumes.

**DO NOT** get in eyes. CORROSIVE to the eye. Potential skin sensitizer.

Avoid contact with eyes, skin and clothing. Harmful if swallowed. Wash exposed areas of skin well after handling and before eating, drinking and smoking. Wash contaminated clothing with soap and hot water before reuse. Wash separately from other clothing. Do not wear contaminated shoes.

## **FIRST AID**

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or a doctor. Do not give anything by mouth to an unconscious person.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth to mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical advice.
