**DIRECTIONS FOR USE:** Shake well before use. Remove pets, birds and fish bowls. Open cabinets and doors to areas to be treated. Shut off fans and air conditioners. **Put out all flames and pilot lights.** Do not spray near or over furniture, plastic, painted or varnished surface. Equipment or furniture should be covered. Close doors and windows. Point valve opening away from face and eyes when releasing.

**TO OPERATE VALVE:** Product can be used manually or valve can be locked in open position for total release. To lock valve in open position for automatic discharge, depress valve lever down firmly until it clicks and stays depressed. For best results, first spray distant rooms manually spraying towards ceiling. Four to six seconds is ample for average room 3mx3mx3m (10ftx10ftx10ft). Also spray into cracks and crevices.

Place can on stand or table in centre of unobstructed area, then lock valve down. Leave area at once and keep closed for 2 hours before airing out. When finished, open all windows and doors and ventilate for 30 minutes.

**TO KILL BED BUGS:**

Spray (light coating on) mattress, particularly around seams and tufts. Take bed apart, spray all joints. Also spray cracks, crevices, baseboards and other possible hiding places around the room. For mattresses: spray, then air until completely dry at least 4 hours before re-use. Vacate room after treatment and ventilate before reoccupying. Repeat as required.

**FLEAS:** Spray infested areas such as pet's bed and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor covering where these pests may be present. Remove old bedding after treatment. Insects must be contacted to be killed. Do not spray furniture or carpets that people regularly contact. **DO NOT SPRAY PETS.**

**SPACE SPRAY:** (Adjust nozzle to deliver the mist spray pattern) (Spray) to control house flies, mosquitoes, wasps, biting midges and flying moths. Close doors and windows. Direct mist upwards in sweeping motion to all parts of the room especially windows and other light sources. Apply 6-10 seconds burst per 30m<sup>3</sup> of space. Whenever possible, keep doors and windows closed for 15 minutes after each treatment. Also direct mist into areas where insects are present. Keep spray at least 1 m from interior walls, fabrics and furniture. Ventilate treated areas for 30 minutes before re-entry.

**For Indoor Ornamental Plants:** See front panel for insects killed. Carefully spray with slow sweeping motion in short bursts at intervals to cover upper and lower surfaces of leaves. Keep 30 cm to 45 cm away from the plants to avoid wetting the foliage. A light spray kills pests effectively. Not all species or varieties have been tested for sensitivity. Apply to individual plants or small areas of plants and wait to determine if plant damage (phytotoxicity) occurs prior to treatment of larger areas.

**SURFACE SPRAYING:** Spray to control Cockroaches, spiders, crickets, ants, carpet beetles, centipedes and silverfish. Spray hiding places such as baseboards, moist areas, openings around sinks, drains and pipes, behind cabinets and storage. Repeat spraying in two weeks or when necessary. This product will kill exposed insects only and has no residual activity.

**CAUTION:** Do not use in food storage handling, or service establishment as a total release bomb with valve locked open.

**FOR OUTDOOR AND GARDEN USE:** Spray with valve in manual position. For use on such plants as Asters, Azaleas, Begonias, Chrysanthemums, Dahlias, Delphiniums, Gladioli, Irises, marigolds, Petunias, Roses and Snapdragons. Also for use on evergreens and small ornamental deciduous trees, shrubs and vines. See front panel for insects killed.

For best results, spray in evening, or on cloudy days when air is still. Use slow, sweeping motions. Keep can 45 cm from plants. Avoid wetting foliage with spray. Spray rows at the rate of 30 cm (12 in) per second. For Heavy growth, spray row on both sides, Repeat when needed. Spray with caution on young plants and new growth. Do not spray garden when temperatures exceed 32°C (90°F).

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN Do not use in presence of open flame or spark. CONTENTS UNDER PRESSURE. Container may explode if heated. Do not expose to temperature above 50°C (122°F). Do not puncture or incinerate. Harmful if swallowed. Avoid breathing of vapor. Avoid contact with skin or eyes. Do not remain in treated areas. Food should be removed or covered during treatment.

All food processing surfaces should be covered during treatment or thoroughly cleaned before use. Do not spray on plastic, painted or varnished surfaces or directly into electronic equipment such as radios, TVs, computers, etc.

**STORAGE:** Keep product in cool and dry place, away from open flames and heat sources.

**DISPOSAL:** When container is empty, press button to release all pressure then dispose in household garbage. This container may be recycled in communities where (steel) aerosol can recycling is available. Before offering for recycling, empty the can by using the product according to the label (DO NOT PUNCTURE OR INCINERATE). If recycling is not available, contact your municipality or provincial Ministry of Environment for disposal information.

**FIRST AID:**

**IF SWALLOWED**, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. **IF ON SKIN OR CLOTHING**, take off contaminated clothing.
