DIRECTIONS FOR USE:

To be used only in the manufacture of an herbicide which is registered under the Pest Control Products Act.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Severely irritating to eyes. **DO NOT** get in eyes. May cause sensitization. Avoid contact with skin and clothing. Avoid breathing dusts. Wash exposed skin thoroughly after using.

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
