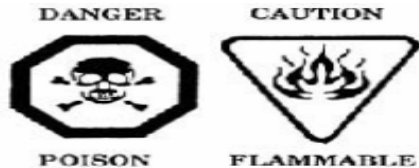

**POTENTIAL SKIN SENSITIZER****DIRECTIONS FOR USE:****Oilfield Applications:**

Use at 100 ppm active ingredient based on water content of oil and gas field water systems until bacterial control is achieved. Inject at a point that will ensure uniform mixing.

Maintenance dosage: 10-25 ppm.

**FIRST AID:**

If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Corrosive to eyes and skin. Avoid ingestions, inhalation and contact with skin, eyes and clothing.

Wear goggles or a face shield, chemical-resistant gloves, long pants, a long sleeved-shirt, shoes and socks during mixing/loading, clean up and repair. Formaldehyde can be released during use of this product. It is recommended that this product not be used in circumstances that would result in formaldehyde air concentrations in the workplace exceeding the exposure levels established by occupational health and safety authorities in your jurisdiction. If values exceed this level, it is recommended that NIOSH approved respiratory protection be worn.
