DIRECTIONS FOR USE:

This product is to be used only in the manufacture of a product which is registered under the *PEST CONTROL PRODUCTS ACT*.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Fatal or poisonous if swallowed. Do not get in eyes or on skin. Do not breathe dust. Do not contaminate feed or food. Wash hands, arms, and face thoroughly with soap and warm water before eating or smoking. Wash all contaminated clothing with soap and hot water before reuse.

- IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth if possible. Call a poison control center or doctor for further treatment advice.
