## **PRECAUTIONS**

### **PREVENT ACCESS BY UNAUTHORIZED PERSONNEL**

Do not get in eyes or on clothing. Harmful if swallowed or absorbed through the skin. Avoid contact with skin, eyes or clothing. Harmful if inhaled. Avoid inhaling/breathing dusts, vapours or spray mist.

DO NOT discharge effluent containing the product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

### **FIRST AID**

**Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.**

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

### **TOXICOLOGICAL INFORMATION**

Treat symptomatically.

### **ENVIRONMENTAL PRECAUTIONS**

TOXIC to aquatic organisms and non-target terrestrial plants.

Do not contaminate water when disposing of equipment washwaters.

Caution should be exercised when handling this product at mixing and loading sites to prevent contamination of groundwater supplies. Use of closed systems for mixing or transferring this pesticide will reduce the probability of spills. Placing of the mixing/loading equipment on an impervious pad to contain spills will help prevent groundwater contamination.

Do not contaminate water used for domestic purposes.

### **STORAGE**

Store in original container in a secured dry storage area. Prevent cross-contamination with other pesticides and fertilizers. Keep away from food or feed. Do not store at temperatures above 50°C for extended periods of time. If the container is damaged or spill occurs, either use the clean product immediately or sweep up the spilled granules and dispose of as waste.

### **DISPOSAL**

Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal and provincial regulations. For additional details and clean up of spills, contact the manufacturer and the provincial regulatory agency.
