#### **PRECAUTIONS**

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Harmful if inhaled. Avoid inhaling or breathing dust.

#### **FIRST AID**

If on skin or clothing, take off contaminated clothing. Rinse skin **IMMEDIATELY** with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**If in eyes,** hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

# **TOXICOLOGICAL INFORMATION**

No specific symptoms of poisoning are known for this product. If ingested, nausea, vomiting, diarrhea and abdominal pain may occur. Treat symptomatically.

# STORAGE
