DIRECTIONS FOR USE

ACTICIDE® MV 14F-W MANUFACTURING CONCENTRATE is sold for industrial use only. To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*.

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Fatal or poisonous if swallowed. DO NOT get in eyes, on skin or on clothing. Harmful if inhaled. Avoid breathing vapours and spray mists. Corrosive to eyes and skin. Potential skin sensitizer. May cause allergic skin reaction.

Wash skin thoroughly with soap and water after handling. Remove contaminated clothing and wash separately from other laundry before reuse. Put on clean clothing. Discard clothing or other absorbent materials that have been drenched or heavily contaminated with this product.

Users should remove personal protective equipment immediately after handling this product. Wash the outside of gloves before removing. Follow manufacturer's instructions for cleaning/maintaining personal protective equipment. If no such instructions for washables exist, use detergent and hot water.

Wear chemical-resistant coveralls over a long-sleeved shirt, long pants, chemical-resistant gloves, socks, chemical-resistant footwear and a full-face respirator with a NIOSH-approved organic-vapour-removing cartridge with a prefilter approved for pesticides, or a NIOSH-approved canister approved for pesticides, during mixing, loading, clean-up and repair.

ENVIRONMENTAL PRECAUTIONS

This product is toxic to fish and other aquatic organisms. FIRST AID

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

TOXICOLOGICAL INFORMATION

Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsions may be required. Treat symptomatically.

STORAGE

Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. This product is corrosive to mild steel. Do not store or transport in unlined metal containers.

DISPOSAL
