### **DIRECTIONS FOR USE**

To be used only in the manufacture of a plant growth regulator which is registered under the *Pest Control Products Act*.

### **PRECAUTIONS**

#### **PREVENT ACCESS BY AUTHORIZED PERSONNEL.**

Wash well after handling and before eating, drinking and/or smoking. Wash contaminated clothing with soap and hot water before re-use. Do not wear contaminated shoes.

### **FIRST AID**

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not include vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest control Product Registration Number with you when seeking medical attention.
