PRECAUTIONS

- PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.
- Avoid contact with eyes, skin, and clothing.
- Do not breathe dust or vapor.
- Wear a NIOSH-approved respirator, protective clothing, and chemical- resistant gloves when handling.
