FIRST AID

DIRECTION FOR USE:

DO NOT apply to any body of water

BLACKWATER: To treat 90 liters (20 gal), pour 90 ml (3 oz.) of **RV-Boss™ Holding Tank Treatment – Regular Formula** in the toilet bowl.

GREYWATER: To treat 90 liters (20 gal), dilute 45 ml (1-1/2 oz.) of **RV-Boss™ Holding Tank Treatment – Regular Formula** into 500 ml (17 oz.) of water and pour down the sink.

Avoid contact with chrome

For better results do not use **RV-Boss™ Holding Tank Treatment – Regular Formula** in combination with other chemical products.

STORAGE: KEEP FROM FREEZING. Store this product away from food or feed. Do not store on concrete.
