FIRST AID

DIRECTION FOR USE:

DO NOT apply to any body of water

1. Flush the tank. Rinse if equipped with rinsing jets or fill with clear water and flush a few times.
2. Once well rinsed, close the evacuation trap and fill the tank at about 50% capacity with water.
3. For a 180 liter tank (40 gal) pour 185 mL (6.3 oz.) of **RV-Boss™ Level Gauge Cleaner** and finish filling with water.
4. Let stand 2 to 5 days (the longer the period, the better the results).
5. Drain and rinse the tank.

NOTE: Dirt-encrusted indicators may require additional treatments. Do not use with other products. To avoid recurrence of clogged indicators, use the RV-BOSS™ products for regular treatment of waste water and follow the instructions. **DO NOT USE IN FRESH WATER TANK.**

STORAGE: **KEEP FROM FREEZING.** Store this product away from food or feed. Do not store on concrete.

DISPOSAL: **DO NOT** reuse the empty containers. Dispose in household garbage. Unused or partially used products should be disposed at provincially or municipally designated hazardous waste disposal sites.
